#### A. Accommodation and Property Rentals

KumaShops acts solely as an advertising directory for houses and rooms to rent. We do not own, inspect, manage, or execute leases for any listed property. Users are solely responsible for executing independent due diligence, inspecting physical spaces, verifying landlord identity, and ensuring cross-border transactions comply with local rental regulations.
